### ELIGIBILITY

All members of the PSNR (new members are welcome) are invited to submit works for a juried member's show hosted by the Brown's Gallery in Boise, Idaho. Work must be original fine art, created solely by the artist within the last three years.

Only soft pastels by PSNR members will be shown. Please make sure that your 2010 membership dues have been paid. If you are not a member, remit a \$30 annual membership fee to PSNR before entering this show. You may mail a check to our treasurer at Deborah Gill, 1130 Lowell Dr., Idaho Falls, Idaho 83402 or you may pay online by PayPal on our website at [www.psnr.net](http://www.psnr.net) on the contact page.

### RECEPTION

There will be an evening reception Thursday July 1st from 5pm to 9pm at Brown's Gallery. The general public and members of the PSNR are invited to attend.

### ENTRY FEE

A non-refundable entry fee of \$20 for up to three entries.

### SIZE and FRAMING

There are no subject matter or style restrictions, but pieces must be framed and ready for hanging! No sawtooth hangers.

### DEADLINE

Entries must be received no later than May 15th. You may submit by slide, photo or digital files on disk. If submitting by jpeg, please send your images in jpeg format, in no larger than a 300 dpi image and with the image no larger than 5" x 7". Make sure it is a clear example of your piece.

### SALES

Sales will be handled by the Brown's Gallery and a

40% sales commission will be retained. Sales proceeds will be forwarded to artists within 30 days of the close of the exhibition.

**JUROR:** Works will be juried for inclusion in the show by the gallery owner and all works must be for sale.

### NOTIFICATION

You will be notified by June 1st if your work has been accepted. Accepted work will be due by June 20th. Paintings must be adequately framed and ready to hang. **AGAIN - NO saw-tooth hangers!**

Artists will be responsible for hand delivery or shipping and insuring of their own work. Insurance value is typically 65% of retail value. Neither PSNR nor Brown's Gallery may be held responsible for loss or damage from any cause. Refer to our website instruction for shipping hints if necessary. **NO packing peanuts!!!**

If your work is accepted, it **MUST** remain in the show until the closing of the show unless sold by Brown's Gallery. **NO EXCEPTIONS.** Shipping of unsold work is at the cost of the participant. Shipping instructions will be sent upon acceptance into the show.

**ENTRY INFORMATION** - When you send slides, photos or a disk of digital entries, you **MUST** include a self-addressed, stamped envelope if you want them returned. Nothing will be returned without complete information, envelope and return postage.

Label slide or photo submissions with title, size, and artist's name. If you send digital entries on disk, please label your disk with your name and address. Be sure to include your entry form and fee and send submissions to:
