STAMP

WORK ELIGIBLE

Open to all artists working in the Pastel Medium; **NO OIL PASTELS**. Traditional, contemporary and abstract works of all subjects and styles, not previously in a CPS show, are eligible. **Works must be original, i.e., not copied from works or photographs by others, and not done in any classroom, workshop, or under the supervision of an instructor.** Works must be completed within the last 3 years with predominately 80% soft pastels, and must be identical to accepted digital entry. Size limit including frame: 60" high and 48" wide. Artwork must be securely framed under glass or Plexiglass and be ready to hang with adequate screw eyes and wire. **No saw-tooth hangers.** Neutral mats please. Mattatuck Museum and CPS assume no liability for loss or damage of shipped art (glass is not recommended).

PROCEDURE FOR ENTRY

Each artist may submit up to three entries. All entries will be digital and submitted on a **single CD** containing only the images intended for submission. No email entries accepted. CDs will not be returned. Improperly marked or prepared CDs will be disqualified. Follow preparation instructions carefully. **1.** Set camera for a very high quality image. Use a tripod & make certain camera is perfectly square and level with painting. **2.** Transfer image to computer. Make copy of image and work with the copy. Crop out mats, frames, or untidy edges – only your painting should appear in the image. Do not make computer enhancements to your image. **3.** Resize to 700 pixels on the longest side – 700 pixels wide for horizontal image or 700 pixels tall if vertical. **4.** Resave at resolution 300 dpi. **5.** Save as high quality jpg. **6. Files should be saved as: last name of artist-title.jpg.** For example: DeSomma-IntotheLight.jpg (abbreviate title if lengthy). **7.** Neatly print on CD with permanent marker: name, title, HxW, email address. Make checks payable to "CPS 2010 Renaissance Show" and send **First Class Mail** with CD, completed entry form and #10 SASE to: Rita Caldwell, 18 Tandem Drive, Bethany, CT 06524.

FEE STRUCTURE

Members: \$25 for 1 or 2 digital images, \$30 for 3 digital images. **2010 dues must be paid.** Non-members: \$30 for 1 digital image, \$40 for 2 digital images, and \$45 for 3 digital images. Entries from outside U.S. must be paid with money order in U.S. currency. **Incomplete entries will be declined and entry fee will not be refunded.**

Details will be sent with acceptances. Shipped work must arrive at shipper by Wednesday, September 22, 2010.

SALES

A 30% contribution will be taken on all work sold. If work is listed NFS, the value must be given. NO POR.

REMOVAL

Exhibited work must be picked up after the demo on **Sunday, October 24, 2010 from 3-4 PM.** All work not called for will be stored at the shipping center with a minimum \$20 pick-up and storage fee.

HOLD HARMLESS AGREEMENT

All work will receive careful handling by competent staff; however, The Mattatuck Museum and the Connecticut Pastel Society, or anyone connected with this exhibition cannot be held responsible for the loss or damage to any work of art submitted for exhibition consideration. All work submitted is subject to this condition, which must be accepted by all participants. Signature on entry form constitutes agreement. We recommend artists carry their own insurance.
